- Provide exceptional customer service by being courteous, friendly, and professional when interacting with customers.
- Handle cash and card payments, provide change when necessary, and ensure accurate transactions.
- Maintain a clean and organized vehicle, ensuring it is in good working condition.
- Follow all traffic laws, safety procedures, and company policies during deliveries.
- Assist with order preparation, answering phones, and other restaurant duties when not making deliveries.
- Report any delivery issues (e.g., incorrect address, customer complaints) to management immediately.
- Ensure food and drink items are handled properly to maintain their quality.
- Participate in team meetings and contribute to improving the overall customer experience.

- Exposure at times to inclement weather.
